

Disclosure Log

Dungog Shire Council's disclosure log is a record of information that Council has released in response to a formal application from an individual or organisation under the Government Information (Public Access) Act 2009 (GIPA Act). Council considers the information contained in the log to be of interest to other members of the community.

The disclosure log sets out the date the decision was made to release the information, description of the information released and details of how the information can be accessed. Details are entered into the disclosure log when the access application has been decided, and any review time limits have expired.
